## Journeying Together on the Rule of Life

It is a great joy each year to gather as Churchwardens, Clergy, Sidespersons, PCC members, and others who support our church life. The annual visitation services are a legal formality and a chance to celebrate together.

Last year Bishop Paul launched the Rule of Life to help us be better followers of Jesus. It is an answer to the simple question, what do disciples do? And if we could all be encouraged to do these things, would we be better disciples?

At this stage some people will still be saying, what Rule of Life? Others might complain they have heard too much about it. The question is are we all doing it? The idea is simple concerning an inner journey of **Pray, Read Learn** – combined with an outer journey of **Tell, Serve and Give**.

As I visit churches I get the impression that in some churches perhaps relatively few will be following all aspects of the Rule of Life. I hope that the visitations will help us all feel encouraged and challenged by this to help us build a bigger church making a bigger difference.

Do we have a regular pattern of daily **prayer** and bible **reading**? I try and say the daily morning and evening prayer 6 days a week and find this structure really helpful to me.

**Learn** is asking about being part of a course or small group in which our faith can develop. Churches with courses and groups are much more likely to grow. They will also be better at looking after each other.

**Tell** is about creating the culture and confidence in which explaining what the Christian faith means to us, becomes as natural as speaking with passion about our other interests.

**Serving** our community is a way in which people experience the love of the church through our act of service.

**Giving** generously has to be a key piece – and we have many generous givers of finance, time and talents – but this needs to be continually taught and understood.

The Rule of Life is not everything about the Christian faith, but if we all took it seriously, it would strengthen the life and effectiveness of our churches and increase the blessings in our communities.

So as we gather, we rejoice and give thanks for all the blessings that we have received and commit ourselves to being better disciples and with God's help entering into the Rule of Life, teaching and helping others to do the same.

## Called to Pray – the starting point for the Rule of Life

When he launched the Rule of Life, Bishop Paul was keen to keep it simple for all to be involved in. Prayer is simple but some people can find the idea of prayer daunting. Yet we have a great resource to help us in the words of the prayer that Jesus taught us, the Lord's Prayer. Most people have a version of the Lord's Prayer committed to memory. It gives us a rhythm and pattern for all our prayer. It frames a time of prayer with God.

So the simple call to prayer is to pray the Lord's Prayer every day. If you do that already then great. But when you do, pray it as part of the worldwide communion of Christians who daily lift their hearts to God. Simply start your prayer by saying "together with all disciples in the Diocese of Liverpool and across the world, as our saviour taught us so I pray Our Father..."


## Called to Read – getting into a regular pattern of Bible reading

The second premise of the spiritual disciplines that the Rule of Life is founded on is reading. Specifically reading the Bible. It is clear that by engaging with the Bible texts we can start to understand what God wants from us in our lives. Through the Bible we gain comfort, challenge and inspiration.

The challenge to read comes in two forms. Firstly we are challenged to get in the habit of reading. You may already have a daily pattern of Bible reading. That's great. Carry on with your daily readings, your reading notes, your online pattern of reading. Whatever works for you? If you don't have a regular pattern of reading then try to start. You could start by reading the Gospel of Mark or you could find another pattern of Bible reading.

The other challenge is to join with others in Reading the book of Jonah over the summer. During this time we will be putting together challenges and encouragements for us to read that book across our diocese. It will be great to see you involved.

### Unique research bolsters our advice for churches on slips and trips

Although churches are generally low-risk environments, slips and trips remain the most common cause of injury. In some cases, these can be severe, so taking sensible and adequate precautions is essential. Sometimes, this is more difficult in church premises, usually because of design constraints or the heritage fabric of the building itself. Here, it is usually necessary to consider a wider range of precautions.

We understand this challenge, and it's why we have teamed up with leading health and safety researchers at the Health and Safety Laboratory (HSL) to look at the problem. We have conducted research across a range of historic buildings (including churches) with a view to developing practical advice in the prevention of slips and trips. This is in a way that is both sympathetic with the history of the building and is cost effective.

## Allchurches announces record giving and changes to grant programmes

In 2019, Allchurches Trust, owners of Ecclesiastical, is making changes to its giving that will place even more of an emphasis on helping organisations in less-affluent areas.





The changes have come about following a Strategic Grants Review, which set out to ensure that the Trust continues to meet the needs of its beneficiaries

and make the greatest possible impact with the funds available. The aim is to improve effectiveness, transparency and reporting, including for annual grants to dioceses and cathedrals.

These annual grants are now guaranteed until 2022, facilitating longer-term, strategic planning. At the same time, the Trust aims

to steadily make a greater amount of funding available to churches, charities, dioceses and cathedrals that apply for grants to fund projects in their communities.

As well as giving a higher percentage of the total project cost, Allchurches has doubled the uplift on grants to projects in areas of greatest need.

Annual grants are also now allocated based on population and the degree of deprivation of the area, and dioceses and cathedrals have been asked to provide more information about what they intend to spend their grant on and report back on the impact that the money is having.

Chairman of Allchurches Trust, Sir Philip Mawer, said: "We've already heard about some great initiatives being funded by our annual grant, including a youth outreach partnership project called Growing Faith for Generations (GF4G) in the Isle of Man. We're keen to work with dioceses to share these stories about the good work our funding is helping to enable in their parishes."

## Helping us be good stewards

One of the big challenges we all face is that of giving. Stewardship is an important and necessary part of church life and was a topic that Jesus spoke about more than any other in his ministry. So we need to take this seriously.

We have been very successful in our diocese in encouraging churches to take part in the Parish Giving Scheme so many are already seeing its benefits. The scheme is a simple direct debit scheme which reduces the amount of time Treasurers and Giving Officers need to devote to collecting money. A flexible system which, with permission, increases the level of giving every year so givers don't need to worry and churches get a more guaranteed level of income. Easy to manage, this scheme is proven to be the best, most reliable method for ensuring planned giving.

Contactless payment systems are everywhere. In every high street, on every market at every visitor attraction. They can now come to your church and are ideal for helping the one-off visitor, the christening guest or wedding couple to pay more easily. There are many different types of system being introduced to churches including those that can be used instead of a collection plate.



To be an Eco Diocese we need a plan and a champion that will spur us to having a proportion of our churches rated Bronze, Silver and Gold as well as a rating for St James House. We will also need strong ethical and environmental policies.

So our lead will be Annie Merry and Faiths4Change, the flagship charity established by our diocese. Annie will work alongside Phil Leigh, our Diocesan Environmental Officer, to inspire, motivate and lead us towards being an Eco Diocese. Find out more on our website.
